AN ACT

to repeal the ⁷[Khyber Pakhtunkhwa] Chashma Right Bank Canal Project (Control and Prevention of Speculation in land) Ordinance, 1971.

WHEREAS it is expedient in the public interest to repeal the Preamble ⁸[Khyber Pakhtunkhwa] Chashma Right Bank Canal Project (Control and Prevention of Speculation in Land) Ordinance, 1971 (⁹[Khyber Pakhtunkhwa] Ord. No. V of 1971);

It is hereby enacted as follows:—

- 1. (1) This Act may be called the ¹⁰[Khyber Pakhtunkhwa] Chashma Short title and Right Bank Canal Project (Control and Prevention of Speculation in Land) commencement. (Repeal) Act, 1987.
 - (2) It shall come into force at once.
- 2. (1) The ¹¹[Khyber Pakhtunkhwa] Chashma Right Bank Canal Repeal and saving. Project (Control and Prevention of Speculation in Land) Ordinance, 1971 (¹²[Khyber Pakhtunkhwa] Ord. No. V of 1971), is hereby repealed.
- (2) Notwithstanding the repeal of the ¹³[Khyber Pakhtunkhwa] Chashma Right Bank Canal Project (Control and Prevention of Speculation in Land) Ordinance, 1971 (¹⁴[Khyber Pakhtunkhwa] Ord. V of 1971), anything done, action taken or order passed under the said Ordinance shall be deemed always to have been validly done, taken or passed.
