### AN **ACT**

to amend the <sup>5</sup>[Khyber Pakhtunkhwa]. Finance Ordinance, 1983.

WHEREAS it is expedient to amend the <sup>6</sup>[Khyber Pakhtunkhwa] Finance Ordinance, 1983 <sup>7</sup>[Khyber Pakhtunkhwa] Ord. No. VII of 1983), for the purposes hereinafter appearing;

Preamble.

It is hereby enacted as follows:—

(1) This Act may be called the <sup>8</sup>[Khyber Pakhtunkhwa] Finance (Amendment) Act, 1986.

Short title and commencement.

- (2) It shall come into force at once.
- 2. In the <sup>9</sup>[Khyber Pakhtunkhwa] Finance Ordinance, 1983 (<sup>10</sup>[Khyber Pakhtunkhwa] Ord. No. VII of 1983), in section 2, in clause (d), the full stop appearing at the end shall be replaced by a comma and thereafter the following shall be added, namely:

Amendment of section 2 of <sup>11</sup>[Khyber Pakhtunkhwa] Ord. VII 1983.

"but shall not include Dar-ul-Ulooms and Deeni Madaris having no primary, middle or high classes.".

The <sup>12</sup>[Khyber Pakhtunkhwa] Finance (Amendment) Ordinance, Repeal. 1987 (<sup>13</sup>[Khyber Pakhtunkhwa] Ordinance No. VII of 1986), is hereby repealed.
