Dated Quetta, the 26th February, 2003.

No. PAB/Legis: V (2)/2003. The Balochistan Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) (Amendment) Bill, 2003 having been passed by the Provincial Assembly of Balochistan on 25th February, 2003 and assented to by the Governor of Balochistan, is hereby published as an Act of the Provincial Assembly:-

THE BALOCHISTAN SPEAKER'S AND DEPUTY SPEAKER'S (SALARIES, ALLOWANCES AND PRIVILEGES) (AMENDMENT) ACT, 2003. (BALOCHISTAN ACT NO. II OF 2003).

(First published after having received the assent of the Governor of Balochistan in the Balochistan Gazette (Extra Ordinary) dated the 26th February, 2003).

AN ACT

further to amend the Balochistan Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975 (V of 1975).

Preamble

WHEREAS it is expedient further to amend the Balochistan Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975, (V of 1975) in the manner hereinafter appearing:

It is hereby enacted as follows:-

Short title and Commencement

1. (1) This Act may be called the Balochistan Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) (Amendment) Act, 2003.

(2) It shall come into force at once.

Amendment of Section 5 of Act V of 1975.

2. In the Balochistan Speaker's and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975 hereinafter referred to as the said Act in section 5 for the words "five thousand rupees and four thousand rupees" the words "thirty-two thousand rupees and twenty-seven thousand rupees" shall be substituted.

Amendment of Section 6 of Act V of 1975.

3. In the said Act, section 6 (b) in clause (i) of sub-section (4), for the words "twenty thousand" the words "twenty-five thousand" shall be substituted.

(a) in sub section (3), for the words "forty thousand rupees" and that of the Deputy Speaker "thirty thousand rupees" the words "three hundred thousand rupees" and that of the Deputy Speaker "two hundred thousand rupees" shall be substituted.

Insertion of New Section 6-B in Act V of 1975.

4. In the said Act, after section 6-A, the following new section shall be inserted, namely:-

"6-B Utility Allowance. The Speaker and Deputy Speaker shall be entitled to receive Utility Allowance at the rate of rupees "fifteen thousand and twelve thousand" respectively per month.

Amendment of Section 9 (1) of Act V of 1975.

5. In the said Act, in section 9-(a) in sub section (i) for the words "treated as a government servant of the first grade" the words "entitled to get five hundred and fifty rupees as daily allowance", shall be substituted.

(b) in clause (a) of sub section (2), for the words "economy class" the words "business class" shall be substituted.

**Amendment of
Section 13-A of
Act V of 1975.**

6. In the said Act, in section 13-A for the words "rupees five thousand and four thousand" the words "thirty-two thousand rupees and twenty-seven thousand rupees" shall be substituted.

**Amendment of
Section 15 of
Act V of 1975.**

7. In the said Act, in section 15, for the words "three thousand rupees and one thousand and five hundred rupees" the words "six thousand each" shall be substituted.

**Substitution of
Section 15-A of
Act V of 1975.**

8. In the said Act, for section 15-A the following shall be substituted:

"15-A. A sum of rupees **four hundred thousand and two hundred thousand** per annum (with conditions for its use) shall be placed at the disposal of Speaker and Deputy Speaker respectively for making discretionary grants in such manner as may be prescribed."
