

SIND ORDINANCE NO. I OF 1970

THE WEST PAKISTAN BOARD OF REVENUE (SIND AMENDMENT) ORDINANCE, 1970

[30th July, 1970]

An Ordinance to amend the West Pakistan Board of Revenue Act, 1957, in its application to the Province of Sind.

WHEREAS it is expedient to amend the West Pakistan Board of Revenue Act, 1957, in its application to the Province of Sind, in the manner hereinafter appearing;

Preamble.

NOW, THEREFORE, in pursuance of the Martial Law Proclamation of 25th March, 1969, read with the Provisional Constitution Order, and in exercise of all powers enabling him in that behalf, the Governor of Sind is pleased to make and promulgate the following Ordinance :-

1. (1) This Ordinance may be called the West Pakistan Board of Revenue (Sind Amendment) Ordinance, 1970.

Short title and commencement.

(2) It shall be deemed to have come into force on and from 1st July, 1970.

2. In the West Pakistan Board of Revenue Act, 1957, in its application to the Province of Sind, hereinafter referred to as the said Act, for the words "West Pakistan", wherever appearing, except in sub-section (1) of section 1, the word, "Sind" be substituted.

Substitution of "West Pakistan" by "Sind" in W.P. Act XI of 1957.

3. In section 1 of the said Act -

Amendment of s.1 of W.P. Act, XI of 1957.

(a) for sub-section (2), the following sub-section shall be substituted, namely:-

"(2) It extends to the whole of the Province of Sind."; and

(b) sub-section (3) shall be omitted.

4. In section 2 of the said Act, existing clause (i) shall be renumbered as clause (i-a), and before the clause as so renumbered, the following new clause shall be inserted, namely:-

Amendment of s.2 of W.P. Act, XI of 1957.

"(i) "Additional Member" means an Additional Member, Board of Revenue;".

5. In section 3 of the said Act-

Amendment of s.3 of W.P. Act, XI of 1957.

(i) In sub-section (1), between the word "Members" and word "as", the words "and

Additional Members" shall be inserted: and

- (ii) In sub-section (2), between the word "Member" and the full-stop at the end, the words "or an Additional Member" shall be inserted.

6. In section 5 of the said Act, sub-section (3) shall be omitted. **Amendment of s.5 of W.P. Act, XI of 1957.**
7. In section 6 of the said Act, after sub-section (3), the following Explanation shall be added, namely:- **Amendment of s.6 of W.P. Act, XI of 1957.**
- "Explanation.- In this section and in section 7, the expression "Member" or "Members" shall include an Additional Member or Members."
8. Sections 10 and 11 of the said Act shall be repealed. **Repeal of sections 10 and 11 of W.P. Act XI 1957.**
