

SINDH ORDINANCE NO.XI OF 1974

THE WEST PAKISTAN GOVERNMENT EDUCATIONAL AND TRAINING INSTITUTIONS (SIND SECOND AMENDMENT) ORDINANCE, 1974

[17th August, 1974]

An Ordinance to further amend the West Pakistan Government Educational and Training Institutions Ordinance, 1960, in its application to the Province of Sind.

WHEREAS it is expedient to further amend the West Pakistan Government Educational and Training Institutions Ordinance, 1960, in its application to the Province of Sind, in the manner hereinafter appearing;

AND WHEREAS The Provincial Assembly is not in session and the Governor of Sind is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, the Governor of Sind is pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the West Pakistan Government Educational and Training Institutions (Sind Second Amendment) Ordinance, 1974.

(2) It shall come into force at once.

2. In the West Pakistan Government Educational and Training Institutions Ordinance, 1960 (hereinafter referred to as the Principal Ordinance), in its application to the Province of Sind, in the long title and preamble, the word "Government" shall be omitted.

3. In the Principal Ordinance, in section 1—

(a) in sub-section (1), the word "Government" shall be omitted; and

(b) for sub-section (2), the following sub-section shall be substituted:-

"(2) It shall apply to such institution and from such date, hereinafter referred to as the said date, as may be notified by Government".

4. In the Principal Ordinance, in sections 4 and 5, for the words "the Governor", the word "Government" shall be substituted.

Amendment of sections 4 and 5 of West Pakistan Ordinance XI OF 1960.

5. In the Principal Ordinance, for section 9, the following section shall be substituted, namely:-

Substitution of section 9 of West Pakistan Ordinance XI OF 1960.

Transitional provisions regarding staff.

"9. Every person serving in an institution shall, unless Government in the public interest directs otherwise, become an employee of the Board on and from the said date on such terms and conditions as may be prescribed, which shall not be less favourable than those admissible to him immediately before the said date".

6. In the principal Ordinance, for section 10, the following section shall be substituted, namely:-

Substitution of section 10 of West Pakistan Ordinance XI of 1960.

Property. "10. (1) All Property, movable or immovable, attached to the institution immediately before the said date, shall vest in the Board.

(2) If Government rescinds the notification issued under sub-section (2) of section 1, the property vesting in the Board shall, unless Government in the public interest directs otherwise, stand transferred to Government or as the case may be, to the institution."

7. In the Principal Ordinance, in sub-section (2) of section 11, the fullstop appearing at the end of clause (e) shall be replaced by the semi-colon, and thereafter the following new clause shall be added, namely:-

Amendment of section 11 of West Pakistan Ordinance XI of 1960.

"(f) funds held by or on behalf of the institution, immediately before the said date."

8. In the Principal Ordinance, in clause (a) of sub-section (2) of section 17, for the words "Government servants", the words "persons serving in the institution" shall be substituted.
